DISCLOSURE		
<p>In accordance with Wisconsin State Statute 121.77 (1) any child who physically resides in the Middleton-Cross Plains Area School District for a purpose other than school attendance may be considered a resident student and may be eligible for tuition-free admission.</p> <p>A student who resides with an adult other than his/her parent within the Middleton-Cross Plains Area School District shall be deemed a resident of the district if the student establishes, to the satisfaction of the Superintendent or designee, that the primary purpose for which the student lives in the district is for a reason other than attending a Middleton-Cross Plains Area school. The Middleton-Cross Plains Area School District asks the following information be provided:</p>		
<p><input type="checkbox"/> The <b>resident</b> must provide <u>proof of residency</u>: Proof of residency may include, but is not limited too; lease agreement, purchase agreement, or utility statement of the Middleton-Cross Plains Area School District resident.</p>		
<p><input type="checkbox"/> The <b>resident and parent</b> must each provide a <u>letter of circumstance</u>: This letter should explain the situation for which the student is living with the Middleton-Cross Plains Area School District resident.</p>		
<p><input type="checkbox"/> The <b>resident and parent</b> must call (608-829-9031) to set an appointment to meet at the Middleton Cross Plains Area School District, Registrar's Office, to sign and date this form. Enrollment will not start until residency information is completed.</p>
